1. EXECUTIVE SUMMARY

The CIVIC EPISTEMOLOGIES project lasted sixteen months, from August 2014 until November 2015, with the participation and factual contribution of twelve partners from eleven European countries. The main aim of the project was the development of a Roadmap for Citizen Science, a living document that illustrates paths and conditions to bring citizens, possibly through their associations, into research processes and practices of digital cultural heritage and digital humanities.

CIVIC EPISTEMOLOGIES produced a series of valuable outcomes, which include:

- Roadmap for the Citizen Science;
- Strategic Research Agenda;
- Registry of Resources to support the involvement of citizens in developing the processes of scientific research;
- User Requirements Study, conducted through three Focus Groups;
- Pilot and Case studies.

This report provides an overview of the activities that were carried out during the project and of the main results achieved.

This report is available as a printed booklet. The booklet was distributed at the Final Conference in Berlin – 12-13 November 2015. 3. FINAL REPORT FOR PUBLICATION

The final report is published as a printable document in 2,000 copies and as a downloadable file.

The distribution of the printed copies statted at the final event of the CIVIC EPISTEMOLOGIES project, the "Digital Heritage and innovation, Engagement and Identity" conference in Berlin on 12-13 November 2015.

The report is structured around 12 sections, as illustrated below:

Section 1 describes the project's objectives.

Section 2 introduces to the main project's outcomes.

Section 3 summarises the audiences that the project has targeted.

Section 4 introduces the concept of Citizen Science, presents some concrete examples of Citizen Science in the domain of digital cultural heritage and humanities research, and analyses the major challenges and difficulties in developing the concepts of Citizen Science in this domain.

Section 5 offers a detailed overview of CIVIC EPISTEMOLOGIES's Roadmap, which includes also a brief overview of the project's proposal for the development of a Strategic Research Agenda to support the design, adoption, integration and continued appraisal of Citizen Science approaches in digital cultural heritage and digital humanities sectors.

Section 6 describes the Registry of Resources as a practical tool to support the implementation of Citizen Science initiatives. The Registry has also been a useful instrument to validate the Roadmap.

Section 7 describes the work done in the pilot, an ethnographic study focused on rural Ireland. The pilot adopted participatory approaches, engaging with students, elderly people, and volunteer experts to co-design a digital toolkit for recording, capturing and documenting intangible placebased cultural heritage composed of placenames, oral history and local knowledge heard from relatives and neighbours.

Section 8 summarises the work done in two case studies in the UK. The first case study focused on the participation of volunteers in cultural activities (e.g. theatre, dance, music, art, film making, photography). The second case study worked with a visitor app of the city of Coventry, focusing on the value of Citizen Science, supported by creative uses of ICT, in providing new user perspectives and understandings of the role of local cultural heritage knowledge in local economic regeneration and growth.

Section 9 describes how the project worked with stakeholders, illustrates the wide programme of meetings held to establish factual exchange with target groups and which involved them in the validation of the Roadmap.

Section 10 describes the project online presence, articulated through a set of complementary channels.

Section 11 introduces the final conference held in Berlin where the final version of the Roadmap was presented and distributed.

Section 12 describes the project consortium and provides an overview of the expertise and vocation of all the partners involved in the CIVIC EPISTEMOLOGIES project.

Creative participation in the research is identified as an important element to bring science and society closer together.
