

- Geographic Information Systems have been incorporated

Now we start a new phase in which we offer this information in open mode to citizens for their consultation and reuse to create applications and derivative works. Therefore, data are offered in open mode, with interoperability and with licenses that authorise public dissemination.

Government is providing open data for companies, associations and citizens to use them so they can elaborate new products and services which provide added value, innovation and economic and social boost.

Collaborations have been initiated with other administration bodies with very different functions, such as rural agents, who, on their demand, participate in the elaboration of inventories. After a previous training, and due to their interest, results have been very positive.

Now we are working on different heritage information systems, which will conform a System of systems with a single comprehensive and decentralized data model. It will allow the participation and collaboration of institutions, and other stakeholders that will be able to access our sources and use them to create, if this is the case, new products, etc. The only condition will be to return the updated information. An intermediate space is foreseen for quality control, where our experts in heritage will check the information before incorporating it into our databases.

This new model is designed not only to enrich our sources, but also to make the system sustainable and pursues the permanent updating of inventories.
